**Purpose of Processing for GTS:** identification and contact information, data on the school and the Card, data on the Card Holder status. Processing takes place throughout the card usage, ie until its invalidation under the terms of the Policy. The applicant (or legal representative thereof) agrees to the transfer of personal data to the school and to the regular update of all data by GTS through the school information system.

**Categories of Data Processed by GTS:** contents of this Application, data on the Card usage and data delivered to GTS (contents of this Application, photograph, applicant's address, degree, class, year, personal ID and e-mail address). The applicant (or legal representative thereof) agrees to the transfer of data to the school and to the regular update of all data by GTS through the school information system. Inclusion of the data into the database, sending of sales offers and information about GTS and third parties (including by electronic means) and pro-

filings. This processing is voluntary and is explained in detail in the Policy. **News Subscription:** if the applicant or legal representative (for applicants under 15 years of age) has ticked the appropriate box, they also authorize GTS ALIVE s.r.o. to display selected information in the ALIVE APP or the ALIVE profile and to being sent thereto relevant news by any means (including electronically) according to the conditions set forth in the Policy. **Rights and their Exercise:** the provision of data is voluntary, the Card may be revoked at any time in accordance with the Principles. Each Card holder has the right to the access to, correction, deletion, limitation of the processing, objection against processing and transferability of data - all of these rights are explained in detail in the Policy, including how to exercise them and how to file a complaint with the Office for Personal Data Protection. The consumer rights are explained in the Rules.
